- SB0037 RELATING TO INTRA-COUNTY FERRY SERVICE.  
Introduced by: Baker R, Tsutsui S, English J  
Requires the department of land and natural resources to assign priority mooring space to any intra county ferry service regulated by the public utilities commission that serves a county with a population of less than 500,000 thousand residents and includes at least 3 islands inhabited by permanent residents (Maui county). -- Provides a general excise tax exemption for sale of liquid fuel for intra county ferries operations that serves Maui county. -- Provides that the fuel tax law shall not apply to the sale of liquid fuel sold or used for use by an intra county ferry service that serves Maui county. -- SB0037

- SB0038 RELATING TO TAX ON TOBACCO PRODUCTS OTHER THAN CIGARETTES.  
Introduced by: Baker R, Hemmings F, Green J, English J  
Amends provisions relating to the cigarette tax and tobacco tax law. Redefines tobacco products to include smokeless tobacco and pipe tobacco. Increases the excise tax on the wholesale price of each tobacco product sold. Provides that 33 1/3 per cent of the taxes collected on tobacco products shall go to the community health centers special fund. -- SB0038

- SB0041 RELATING TO THE EMPLOYEES' RETIREMENT SYSTEM.  
Introduced by: Baker R, Ige D, Tsutsui S, English J, Green J  
Amends provisions relating to contributions by certain state agencies. Adds the Hawaii health systems corporations. Defers reimbursement payments to the corporation for employer contributions to the employees' retirement system funds for 5 years. Requires reimbursement of the total deferred amount. -- SB0041

- SB0044 RELATING TO THE HAWAII HEALTH SYSTEMS CORPORATION.  
Introduced by: Baker R, Green J, Ige D, Tsutsui S, English J  
Requires the department of health to assume the total amount of all liabilities and debts or other obligations of the Hawaii health systems corporation that had accrued up to June 30, 1996 while the community hospitals were operating within the division of community hospitals of the department of health. Report to the legislature. -- Requires the Hawaii health systems corporation to bear the sole responsibility for assuming all liabilities and debts or other obligations accrued beginning on July 1, 1996 and thereafter, by the community hospitals operating within the Hawaii health systems corporation. -- Requires the corporation to bear sole responsibility for making all appropriate employer payments into funds of the employees' retirement system beginning on July 1, 1996, and thereafter. Amends provisions relating to contributions by certain state agencies. Adds the Hawaii health system corporation and the employees. -- SB0044

Amends provisions relating to jurisdiction and power. Prohibits the liquor commission within its county to grant an applicable class of license renewal for a bar, business, nightclub, or restaurant that do not comply with the smoking law and to issue a summons or citation for violation. Requires a bar, business, nightclub, or restaurant as a prerequisite for renewal to show satisfactory proof of compliance with signage requirements. Increases fines and a 3rd violation shall result in the revocation of a liquor license. - SB0056

Provides a general excise tax exemption for physicians or osteopathic physicians whose principal place of business is located in a county with a population of less than 500,000. -- Amends provisions relating to excluded service under employment security law. Redefines employment to exclude service performed by physicians or osteopathic physicians whose principal place of business is located in a county with a population of less than 500,000. -- SB0174

Establishes provisions relating to agriculture education program. Transfers administrative authority of the comprehensive agriculture education from the department of education to the department of labor and industrial relations. Appropriation. (\$\$) -- SB0175

Establishes provisions relating to genetically engineered fish and fish products; labeling; identification. Prohibits the sale of genetically engineered fish or genetically engineered fish products unless it is labeled to identify the fish

or fish product is a genetically labeled to identify the fish or fish product as a genetically engineered fish or fish product. -- SB0237

- SB0238 RELATING TO LABELING OF GENETICALLY ENGINEERED CROPS.  
Introduced by: Gabbard M, English J, Green J  
Amends provisions relating to food, drugs, and cosmetics law. Prohibits the sale, offering for sale, or distribution of any farm product grown in Hawaii that is a genetically engineered whole food; is intended for human consumption in the State and does not have affixed to the product a conspicuous label bearing the notice genetically engineered. -- SB0238

Requires any person undertaking an open field production of a genetically engineered plant to notify the department of agriculture of the proposed production. Requires the department of agriculture to make the public information accessible to the public and posted in the department's website. -- SB0239

Establishes provisions relating to credit for non use of plastic shopping bags. Requires each retail establishment that offers goods or other tangible products for sale to establish a policy to provide the consumer with a refund or store credit of 5 cents per bag if the consumer elects not to utilize a plastic shopping bag offered at no additional charge. -- SB0244

Establishes the at store plastic carryout bag recycling program. Requires the operator of a store to establish an at store recycling program that provides an opportunity for a customer of the store to return clean plastic carryout bags to the store. Establishes penalties. Allows the director of health to institute a civil action in any court of competent jurisdiction for injunctive and other relief to prevent violations or to obtain other relief. Establishes provisions relating to plastic carryout bag reduction. Prohibits store operators from providing plastic carryout bags to consumers at the point of sale for the purpose of transporting groceries or other goods. Establishes administrative penalties, injunctive and other relief. -- SB0245

Establishes provisions relating to aquarium aquatic life; collection. Requires the department of land and natural resources to develop and maintain an aquarium collecting white list of aquatic species for each county. Prohibits aquatic specie to be collected or sold for aquarium purposes unless the specie appears on the white list. Establishes fines and imprisonment penalties. -- SB0274

Amends definition of energy efficient vehicle under the Hawaii public procurement code. -- Amends provisions relating to the designation of high occupancy vehicle lane. Authorizes hybrid or energy efficient vehicles to use any high occupancy vehicle lane (HOV) regardless of number of occupants. Requires the director of transportation to develop the means to identify hybrid vehicles and energy efficient vehicles. -- SB0295

Amends provisions relating to permitting process for renewable projects. Deems the application for the permit to be approved if no decision is made within 180 days of application. -- SB0377

Prohibits any person to take, possess, or sell more than 2 of each of the following species of goatfish; kumu, moana ukali, muni, and uhu per day on Maui. Allows a commercial marine dealer to possess and sell more than 2 kumu, moana uakali, muni, and uhu with receipts issued for the purchase. Requires the kumu, moana uali, and muni to be at least 10 inches in length and uhu to be at least 12 inches in length. -- SB0378

Requires the office of elections to develop and implement a vote by mail pilot program to be implemented for the elections in 2010 in 3 representative districts. Act to be repealed on December 31, 2011 (sunset). Appropriation. (\$\$) -- SB0379

Requires the legacy land conservation commission to prioritize consideration of the Maui north shore heritage park for recommendation to the board of land and natural resources to acquire title to the Maui north shore heritage park. -- SB0381

### SB0383 RELATING TO RENEWABLE ENERGY.

Amends provisions relating to the priority permitting process for renewable energy projects. Requires agencies to expedite handling and processing of building permits to install photovoltaic energy systems. Provides for approval if permit application is not granted or denied within 60 days for the existing structure and within 120 days for new structures. -- SB0383

Establishes provisions relating to pedestrian traffic safety devices; newly constructed schools, for public schools, charter schools, and private schools. Requires the department of education, charter schools, and private schools to ensure that there are proper pedestrian traffic safety devices in place and fully operational prior to the 1st day of school. Requires the assistance of the department of transportation, county transportation services department, and county police department. -- SB0384

Amends provisions relating to Iolani palace and the Bernice Pauahi Bishop museum. Requires the comptroller and the State of Hawaii museum of monarch history or the Bernice Pauahi Bishop museum, as applicable, be responsible for the selection of works of art and artifacts for Iolani palace and the Bernice Pauahi Bishop museum. Allows expenditures from works of art special fund for acquisition of works of art for the museum and palace. -- SB0406

Establishes provisions relating to home care agencies; licensing. Requires that all home care agencies be licensed to ensure the health, safety, and welfare of clients. Requires the director of health to adopt rules regarding home care agencies to protect the health, safety, and civil rights of clients of home care agencies; and provide for the licensing of home care agencies. Repealed on June 30, 2014 (sunset). Appropriation. (\$\$) -- SB0415

Appropriation to the department of health for direct health care for the uninsured, which may include primary medical, dental, and behavioral health care. Allows distribution of funds to be on a per visit basis. (\$\$) -- SB0425

Requires psychologist holding conditional prescription certificate continue to hold a current license to practice psychology in Hawaii and continue malpractice insurance, inform the board of the name of the prescribing mental health professional under whose supervision the psychologist will prescribe psychotropic medication, maintain an ongoing collaborative relationship with the doctor of medicine who oversees the patients general medical care. Prohibits psychologist holding a conditional prescription certificate to delegate prescriptive authority to any person. Allows a person to use the title of industrial / organizational psychologist provided that the person registers with the board is professionally competent, holds a doctoral degree and provides psychological services or consultation to organization. Requires the state health planning and development agency report to the legislature, including any proposed legislation and assessing the viability of continuing prescriptive authority for psychologists. -- SB0428

Requires any public or private entity responsible for the inadvertent, unauthorized disclosure of personal financial information to be liable for the costs of providing each person whose personal financial information was disclosed with, at a minimum, a 1 year subscription to a credit reporting agency's services. -- SB0431

Requires that records relative to prescription information containing identifiable patient data shall not be licensed, transferred, used, or sold by any pharmacy benefits manager, insurance company, electronic transmission intermediary, retail, mail order, or internet pharmacy or other similar entity for any commercial purpose. -- SB0449

Amends provisions relating to food, drugs, and cosmetics law. Prohibits any person to manufacture, sell, deliver, hold or offer for sale of any food containing any amount of aspartame or neotame or their derivative compounds in any of their trade names after December 31, 2009. -- SB0576

Allow the chairperson to appoint a hearing officer. -- Amends provisions relating to public utilities commission special fund by adding suspension of collection of public utility fees. Authorizes the public utilities commission to temporarily suspend and to reinstate the collection of public utility fees. -- SB0577

Requires beginning January 1, 2011, all documents and letterhead prepared by or for state or county agencies or offices to include accurate, appropriate, and authentic Hawaiian names and language, including but not limited to macrons and glottal stops printed above the English translations provided that any revision to conform any document or letterhead existing on or before January 1, 2011 to the requirements of this section may be implemented when the document or letterhead requires replacement or reprinting, or otherwise requires revision. -- Amends provisions relating to State language. Requires beginning January 1, 2011 the Hawaiian languages is to be used on all emblems and symbols representative of the State provided that for emblems and symbols existing on January 1, 2011 conformance with this section may be delayed until a replacement for the emblem or symbol is required. -- SB0579

Amends provisions relating to general powers and limitation of the counties. Provides that the counties may exercise their power of condemnation by eminent domain provided that no county shall condemn private property and subsequently transfer that same property to a private entity that expressed an interest in purchasing the same property for development or commercial purposes or private use before the condemnation, except in takings for public utilities, irrigation systems, and affordable housing and community developments, and condemnation of development tracts. -- Amends provisions relating to private property for public use; disposal of excess property. Allows private property to be taken for public use provided that the public use for the purposes of eminent domain powers shall not be construed to include the condemning of private property and the subsequent transfer of that same property to a private entity that express an interest in the purchasing that same property for development or commercial purposes or private use before the condemnation, except in takings for public utilities, irrigation systems, and affordable housing and community developments, and condemnation of development tracts. -- SB0581

Establishes provisions relating to kuleana lands. Requires the office of Hawaiian affairs to hold in trust any unclaimed kuleana lands if the descendants of the native tenants are unknown or cannot be found. Requires the office at least once a year to publish a list of all kuleana lands it holds in trust, including the name of the last known native tenants. Provides that any descendant of a native tenant may make a claim with the office for any unclaimed kuleana.
